



The new NCHC lottery

The project for the second pitch is well underway.... And the concept for a revised lottery with a **£5/month** contribution has been widely welcomed!

The organisations that will help with funding (Sportsmatch, Foundation for Sport & Art, Biffa, Veolia, etc) insist that we raise a reasonable level of funding ourselves or need to know where other funds will come from... for example Biffa insist on 10% match funding. So along with the other ongoing fundraising, this lottery will benefit the club enormously.

NCHC has over 450 members... we hope to get at least 200 participants. This would raise well over £12,500 per year, including gift aid and after payouts.

The prizes: One monthly prize of 5% of monthly pot ($200 \times 5 \Rightarrow \text{£}50$)
One annual prize of 5% of annual pot ($12 \times 200 \times 5 \Rightarrow \text{£}600$)

The lottery will be run through TRF Ltd, Taverham Recreational Facilities, the company that owns the pitch and club-house and is a registered charity - this will allow us to claim Gift Aid. The lottery will be run by Stephen Meek, a famous Norwich City veteran who has been running the NCHC lottery for over 15 years.

To join, you will need to complete two applications:

- 1) A lottery application form, including Gift Aid, which needs to be printed off, completed, signed and sent to Steve.
- 2) A bank standing order mandate which needs to be printed off, completed, signed and sent to your bank OR can be set up online.

You will then be entered in the monthly draw. Prizes will be paid by cheque and the winner's names will be published on the website.
